

Five Initiatives

- 1. Academic Equity: Develop a foundation of high expectations striving toward continual growth that equitably meets the diverse social and academic achievement needs of all learners.
- 2. Social/Emotional Learning: Meet students' mental and behavioral health needs.
- **3. Math Program Review:** Design a math program that is engaging, challenging and fully articulated K-12.
- 4. Academic Engagement: Ensure students have a love of learning, a desire to succeed and are genuinely engaged with their school and education.
- 5. Diversity & Culturally Responsive Teaching: Support diversity and culturally responsive practices to increase the sense of safety and acceptance for all students and to promote empathy.

Close to \$500 million in non-competitive grant money for all Oregon school districts and eligible charter schools.



2019-2020




Student Investment Account

What is the Purpose of the Student Investment Account?

- 1. Meet students' mental and behavioral health needs.
- 2. Increase academic achievement and reduce academic disparities for:
 - Students of color;
 - Students with disabilities;
 - Emerging bilingual students; and
 - Students navigating poverty, homelessness, and foster care; and other students who have historically experienced disparities in our schools.
