



## OPERATIONAL BLUEPRINT FOR SCHOOL REENTRY 2020-21

Updated 7/29/2020

Under ODE’s **Ready Schools, Safe Learners** guidance, each school<sup>1</sup> has been directed to submit a plan to the district<sup>2</sup> in order to provide on-site and/or hybrid instruction. Corbett School District conducted three school community outreach surveys summer 2020 as we planned for instruction in the Fall. A draft reopening Blueprint for the Hybrid Learning Model was presented and discussed at the school board meeting in July and posted on the website along with a one-page summary of the main points. Multiple communications were sent out from the district and building principals describing the planning process and decisions being made. The building principals held a parent meeting in early August to review plans for the fall, answer questions and take feedback.

The district administration team has met with representatives of the classified and certified unions in order to facilitate communication and cooperation. The Director of Student Services has reached out to families of students with disabilities to ensure we plan to meet their individualized needs. The English Language Development Specialist/Homeless Liaison/Migrant Ed Liaison/Fostercare POC has reached out to the parents/guardians of students he serves to provide information and answer questions. We have also reached out to the Confederated Tribes of Grande Ronde, Confederated Tribes of Siletz Indians and the Native American Youth and Family Center to see if these organizations would be interested in consulting on the reopening plan and partnering with us to serve our students going forward. Throughout this process we collaborated with Curriculum & Instruction and Health Services staff from the Multnomah Educational Service District (MESD) and the local public health authority.

In the Fall, we plan to increase our efforts to engage families from traditionally underserved populations through family nights, the administration of the YouthTruth Survey, and the ongoing work of the Equity and Culturally Responsive Practices Initiative that is part of our District Consolidated Improvement Plan.

Due to the Oregon Department of Education reopening metrics we pivoted to a Comprehensive Distance Learning (CDL) model for the first trimester of the school year. This information was communicated to families via district email as soon as the decision was made. Follow up communication will be sent weekly at least until school begins on September 8<sup>th</sup>. The Corbett website has information posted on its front page so parents may access current reopening information in English and other languages as well. If Multnomah County and the State of Oregon have met the required metrics, we plan to open for hybrid instruction at the end of November.

**Describe why you are selecting Comprehensive Distance Learning as the school's Instructional Model for the effective dates of this plan.**

Corbett School District will implement Comprehensive Distance Learning (CDL) from September 8 – November 19 because Multnomah County and the State of Oregon have not met the metrics required for on-site learning. Making the decision in August gives the district time to plan the aligned K-12 professional development the staff will need to effectively implement high quality Comprehensive Distance Learning. It allows teachers time to revise their instructional program to fit the CDL model and gives families time to organize their schedules.

Corbett School District will follow the requirements for CDL outlined in the Comprehensive Distance Learning document released by ODE in July 2020. The district is committed to meeting the needs of all students, especially those from traditionally underserved populations. Staff will continue to review the guidance, review plans (IEP, 504, LEP, TAG) and collaborate with families to ensure individualized needs are being met. At this point there is no need for waivers. The administrative team has reviewed and discussed the CDL guidance and has plans in place to meet all of the requirements. Those plans include:

- A full academic learning experience with instruction based on grade-level or above grade level state content standards in all subject areas.
- Meeting all requirements outlined in HB 13 (Tribal History/Shared History) and SB 858 (Erin's Law).
- Set schedules for classes. The length of the school day will be similar to our regular schedule.
- Continued services for students with disabilities, students eligible for language development services, and students with other individualized needs.
- Consistent and timely student feedback and documented assessment of learning toward state content standards.
- Frequent and ongoing opportunities for families to connect with school staff (group Zoom meetings, virtual conferences, virtual principal chats).
- An emphasis on social/emotional health, including the incorporation of time for check-ins and peer interactions, and the development of a classroom culture, even when the "classroom" is remote.
- Attendance taken daily and attendance updates provided to families frequently.
- An electronic device provided to each student and assistance for families who require internet access, including new connectivity opportunities for all families who lack internet access.
- Access to virtual orientation to ensure all students and parents know and understand virtual tools and procedures.
- Learning opportunities that go beyond a computer screen.
- Pick up meals provided for families eligible for the free/reduced lunch program or those experiencing financial difficulties.
- Professional development opportunities for the staff to ensure they have the tools they need to create an engaging program for students.

The week before school begins the classroom teachers will schedule an individual meeting with each of their families. At this meeting the teachers will gather information about what worked well for students and families and what struggles they experienced during the emergency distance learning in the Spring. Teachers will work with building principals to identify and plan for students/families who may require extra support during the period of CDL.

**Describe the school's plan, including the anticipated timeline, for returning to Hybrid Learning or On-Site Learning consistent with the *Ready Schools, Safe Learners* guidance.**

Corbett School District plans to implement CDL from September 8 - November 19. In early October we will review the metrics and be prepared to continue with distance learning beyond November 19 or pivot to the Hybrid Instructional Model. The 2020-21 calendar was adjusted to move the start date for students from August 31 to September 8. This provided four additional training/planning days for staff to prepare for the implementation of CDL and to participate in the health and safety training necessary for the return to on-site learning. The district has completed the Blueprint for Reopening for the Hybrid Instructional Model and is ready to submit and implement that plan when the metrics indicate it is safe to do so.
