# **NOVEMBER BOND MEASURE** - by Interim Superintendent Dan Wold

We are bringing a bond before the voters next month, but many of us fill out and mail our ballots soon after we receive them. So, I am using this month's column to get information out about the bond. Revenue from the bond will partially address aging facilities and educational changes.

The buildings are in disrepair from age and heavy usage. The district's last bond to fund construction of the grade school was approved 26 years ago. This new \$4 million bond is estimated to cost voters approximately \$1.02 per \$1,000 of assessed property value annually. This is less than the average \$2.58 per \$1,000 of assessed value Corbett taxpayers paid annually over the life of the previous grade school bond. Our facilities are also outdated, as a result of increased technology applications, state and federal mandates, and changes in educational standards, curricular focus, and student demographics.

Corbett School District has also secured a \$3,878,367 capital improvement grant from the state, but these "matching funds" will become available only if this bond is approved. If district voters do not approve this measure, these funds will be diverted to another school district. This grant was allocated based on a lottery; we may not have this opportunity at a future election.

With the combined \$7,878,367 of bond and grant funds, the district plans to relocate the middle school and district offices to the Woodard property (permanent facilities are expected to be created at the main campus if future bonds are approved), and begin to address a portion of approximately \$28 million of identified long-term capital improvement needs.

More specifically, if approved, bond and grant funds are expected to finance or refinance the following capital costs:

- Relocation of middle school to Woodard property
- Relocation of district offices to Woodard property
- Renovation of high school facilities
- Grade school roof repairs
- Seismic improvements to multi-purpose building main campus
- Decommission existing middle school facility
- Furnishing, equipping, and improvements to facilities, including for CTE, Title IX and ADA
- Site improvements, refinance loan for land acquisition and improvements, demolition, and bond issuance costs.

Bonds would mature in a period not to exceed eleven years from issuance and financial audits and oversight will be required. If the bond is approved, the district would establish a citizen oversight committee to ensure that bond proceeds are used for the purposes indicated. The citizen oversight committee would make regular reports to the school board throughout the design and construction process. If our proposed use of Woodard property is not approved by authorities having jurisdiction, including Multnomah County, then funds planned for relocating middle school and district offices to Woodard will be used to accommodate them at the main campus. This fall the Corbett School District will ask parents/guardians, staff, and students in grades 3-12 to complete the YouthTruth Survey. This partnership is a result of the Student Investment Account grant process that was completed last school year. It became clear that we needed a tool to gather ongoing feedback from our school community regarding what we are doing well and what we can improve. The YouthTruth Student Survey is a nationally recognized survey used in hundreds of schools and districts across the country, surveying hundreds of thousands of students. All the surveys are anonymous and individual ratings are not identified in any reports because results are shared at the group level.

The Student Survey asks students about their experiences in the school and with their teachers, including how engaged they are at school, the rigor of their coursework, and their preparedness for the future.

The Family Survey gives parents and guardians the opportunity to provide feedback for their child's school in areas like culture, engagement, relationships, communication and feedback, school safety, and resources.

The Staff Survey gives school-based staff members the opportunity to provide feedback about their experience as staff members in areas like culture, relationships, engagement, professional development and support, and school safety.

The survey window is from October 5th to the 23rd. The link to the Family Survey will be emailed the first week of October. Parents will receive more information regarding the Student Survey from their child's teacher before the survey is administered. Although we want to hear from as many students, families, and staff as possible, participation is voluntary.

The Student Survey and Family Survey are available in multiple language translations which can be selected from a dropdown menu at the beginning of the survey.

Parents who do not want their child to participate should contact the classroom teacher.

Union apprenticeship programs are going to get a boost at Corbett High School on Oct. 22nd when a virtual day of classes will be educating teachers, educators, and influencers about how to merge the everyday classroom with union apprenticeship opportunities. All high school educators from Corbett High School and surrounding school districts are invited.

The event will start with a welcome introduction and end with closing remarks with four breakout block sessions in between. Some of the breakout sessions will include presentations from union representatives that include Apprenticeship 101, Exploration, Plans for the Classroom, Basic Ironworker Skills, Empower Your Students to Promote Apprenticeship, How Math Adds Up in the Roofing Trade, Recruiting and Retaining Women in the Skilled Construction Trade, Sheet Metal Workers, Construction Origami, plus many more unions apprenticeships will be represented.

The workshops will provide an overview of the Registered Apprenticeship System in Oregon, RA partners and the roles they play, and how interested applicants can apply. Many educators and career counselors feel comfortable supporting their students as they navigate the college path, but with apprenticeship programs they may feel unprepared. This workshop aims to change that. Workshop attendees will walk away with a lesson plan, PowerPoint presentation, and lesson materials so they may teach their students about apprenticeship programs with confidence.

Along with the Oregon Department of Education | Higher Education Coordinating Commission Office of Community Colleges and Workforce Development/Bureau of Labor and Industries, these are unions that are sponsoring the event Assessing Union Apprenticeships.

# FROM the CORBETT SD HEALTH ROOM

This has been an unusual start to the school year and now we can add wildfires to this list. My hope is that you and your student(s) are safe and well. This community is strong and works together. We will emerge with closer bonds and great appreciation. Many of us have seen unexpected kindness shown by our neighbors and friends.



It is easy to get focused on the here and now, and rightly so. I would like to encourage you to plan ahead for when our students will return to in-person school.

Recently, my daughter's pediatrician sent out a unique plan for their patients...a drive thru vaccination event. I think it is brilliant. This way, I can schedule an appointment and stay in our car as the medical personnel come to us and give the appropriate vaccine. I do not know how many offices are trying this, but it might be worth asking your healthcare provider if that is a possibility. Flu season will be starting shortly. Your school nurse got her flu vaccine on September 18th. I would encourage those who are able to safely get this vaccine, to put this on your "to-do" list.

"While we can't prevent every cough or sniffle, vaccinations can protect kids and their families from diseases like influenza or whooping cough, which can cause symptoms similar to COVID-19. In areas where communities have to rely on symptoms to decide who should quarantine, the similarity between flu and COVID-19 illnesses could result in more stress for everyone." <u>https://www.shotofprevention.com</u>
